**RULES OF TENANCY** – This contract must be signed, dated and submitted prior to entering the camp for the current camping season.

### **POOL RULES**

***THE SWIMMING COMPLEX IS UNSUPERVISED. SWIM AT YOUR OWN RISK.***

1. Maximum capacity is 30 people per HR in the pool, and the deck area.
2. There is absolutely no swimming after dark.
3. If the pool gate is locked, stay out.
4. Deck furniture is to remain within the enclosure.
5. No food and drink in and around the pool area.
6. Dress appropriately for swimming and sun bathing; remember this is a family campground.
7. No running in the pool area.
8. No diving or jumping in the pool is permitted.
9. Children under 12 years must be accompanied by an adult.
10. Always have a buddy; swimming is at your own risk. Remember, there is NO LIFEGUARD ON DUTY.
11. ABSOLUTELY no pets allowed in or around the pool or deck area.
12. No large floatation devices. No toys other than those provided or approved by owner.
13. Diapers are not allowed in the pool, please use infant swim diapers.
14. Long hair MUST be tied back.
15. Everyone MUST shower before entering and exiting the pool.
16. Only swimmers around the pool deck area.
17. No person infected with a communicable disease or having open sores on his/her body shall enter the pool.
18. No person shall pollute the water in the pool in any manner. Spitting, spouting of water and blowing nose in the pool or on the deck are prohibited.
19. No boisterous play in or about the pool.

***Please read and abide by all signs provided by our Local Public Health Unit that are posted at the pool.***

### **SEPTIC SYSTEM**

1. VERY IMPORTANT: The septic system may only be used for human waste, toilet paper, and typical wash water. Women's feminine products, diapers, food and other trash must be disposed of in the garbage. If you have any questions about personal waste disposal and sewer blockage please enquire with management.
2. Only approved products may be added to septic holding tanks. Chemicals that destroy the active enzymes and bacteria in the septic system are prohibited. i.e.: bleach, anti-bacterial products, many toxic cleaners.

### **TRAILER SALE'S**

INITIAL HERE: \_\_\_\_\_

All trailers 20 years and older cannot be sold on the SITE. If you are selling your trailer on Happy Hollow Campground Inc. property, it must go through our office at a 6% commission rate. All trailers coming in from another Dealer requires a pad fee of \$2500.00 Plus Taxes for setup on site.

1. IF THE APPLICANT CAMPER HAS AN OUTSTANDING HYDRO INVOICE FROM THE PAST YEAR, PLEASE NOTE IT MUST BE PAID IN FULL PRIOR TO THE APPLICANT CAMPER RECEIVING HYDRO FOR THE CURRENT SEASON.

2. THE CAMPSITE IS FOR A FAMILY UNIT TO INCLUDE NOT MORE THAN **TWO (2) ADULTS** AND THEIR DEPENDENT CHILDREN UP TO THE AGE OF **EIGHTEEN (18) that live at home**. TRAILER SUBLET MUST HAVE PRIOR APPROVAL OF THE PARK OWNER AND EXTRA FEES WILL APPLY. (Family Passes are available)

3. OVERNIGHT VISITOR FEES ARE **\$10.00 per car +HST & 10.00 per Adults & \$5.00 per Children under the age of 16**. DAY VISITORS TO THE CAMPSITE WILL BE CHARGED **\$10.00 per car +HST & \$5.00 PER PERSON AND CHILDREN UNDER AND AGE OF 3 IS FEE**. Family Passes **\$350.00 + HST**. To include not more than TWO (2) ADULTS and their dependent children under the age of 16.

4. To secure your lot for 2026 a payment of \$1000.00 is required and must be paid by October 1<sup>st</sup> 2025. If I do not receive payment by October 1<sup>st</sup>. I will assume you are not renewing your contract for 2025 and I will proceed to fill your lot.

A) All personal items must be removed from your lot by October 20<sup>th</sup> 2025.

B) All outstanding invoices must be paid by October 15<sup>th</sup> 2025.

5. Office Hours **8AM – 9PM DAILY**

- a. Visitors may arrive any time after 9AM and must check in upon arrival
- b. All visitors must be checked in prior to 9PM
- c. Visitors with day passes must leave by 11PM
- d. Visitors may not park outside the gates
- e. Please ensure your visitors are aware of these updated hours.

You are responsible for your visitors, please be advised if visitors are not checked in you and your visitors will be asked to leave.

6. THE APPLICANT CAMPERS WILL BE RESPONSIBLE FOR ANY FUTURE TAXES THAT MAY BE BROUGHT INTO EFFECT.

7. NO PERMANENT SHELTERS OR ADDITIONS TO TRAILERS ALLOWED ON CAMPSITE WITHOUT PERMISSION.

8. THE APPLICANT CAMPERS MUST CARRY THEIR OWN TRAILER INSURANCE. FAILURE TO DO SO SHALL NOT FALL ON THE RESPONSIBILITY/LIABILITY OF THE PARK OWNER.

9. THE APPLICANT CAMPERS ARE RESPONSIBLE FOR CUTTING THEIR OWN GRASS. MOWERS AND FUEL ARE SUPPLIED BY THE PARK OWNER. THE MOWERS ARE SITUATED IN THE SHED BY THE ENTRANCE GATE.

10. MINIBIKES, MOTORCYCLES, A.T.V.'S OR GAS POWERED GOLF CARTS ARE NOT ALLOWED IN THE CAMPGROUND WITHOUT SPECIFIC AUTHORIZATION.

11. DO NOT CUT THROUGH OTHER CAMPSITES. RESPECT THE PRIVACY OF YOUR FELLOW CAMPER.

12. THE USE OF BICYCLES, SKATEBOARDS AND ROLLER BLADES ARE STRICTLY FORBIDDEN ON THE HILL. DO NOT RIDE BICYCLES AFTER DARK IN THE CAMP.

13. GARBAGE BINS ARE FOR THE APPLICANT CAMPERS' USE SOLELY. GARBAGE COLLECTION STARTS ON MAY 1 AND ENDS OCT 31. RECYCLABLE, BEER CANS AND ALCOHOLIC BOTTLES GO IN THE STEEL SHED. ALL OTHER RECYCLABLE MATERIAL IS TO BE PLACED IN THE RECYCLABLE BIN WHICH INCLUDES PLASTIC, GLASS, CANS, PAPER AND CARDBOARD.

**WARNING – IF YOU ARE OBSERVED PUTTING ITEMS OTHER THAN RECYCLABLE MATERIAL IN THE BIN, YOU WILL BE CHARGED A DUMPING FEE (\$65.00+).**

14. ALL PETS MUST BE KEPT ON LEASHES AND ARE NOT ALLOWED IN THE RECREATION BUILDING OR POOL DECK AREA. THE APPLICANT CAMPERS ARE EXPECTED TO CLEAN UP AFTER THEIR PET(S). IF BARKING IS A PROBLEM THE APPLICANT CAMPERS MAY BE ASKED TO REMOVE THE ANIMAL. SOME BREEDS SUCH AS PIT BULL AND ROTWEILLER WILL NOT BE ALLOWED.

15. PARENTS ARE RESPONSIBLE FOR THEIR CHILDREN'S BEHAVIOR AT ALL TIMES.

16. MUSIC MUST BE TURNED OFF AT **11 P.M.** QUIET TIME IS FROM **11 P.M.** TO **9 A.M.**

**EXCESSIVE MUSIC, NOISE & GATHERING AFTER 11PM**

**If this is not adhered to a polite written first warning will be issued. A second infraction will require written warning where you will be asked to leave the camp for the period of one week. If a third written warning becomes necessary you will be evicted from this campground. In the future I suggest that large parties and gatherings be held at your homes. Happy Hollow Campground is a family campground for everyone to enjoy and excessive noise and group gatherings are not necessary or welcome. Unless organized & approved by camp owner for special functions.**

17. THE APPLICANT CAMPERS SHALL NOT OPERATE LAWN MOWERS OR POWER TOOLS BEFORE **9 A.M.** PLEASE BE CONSIDERATE OF YOUR FELLOW CAMPERS AT ALL TIMES. ALSO PLEASE NOTE OPERATION OF THE ABOVE IS STRICTLY PROHIBITED ON SUNDAYS. IF THE APPLICANT CAMPERS FAIL TO MAINTAIN THE LAWN MAINTENANCE AT THEIR CAMPSITE, AND THE PARK OWNER HAS TO MAINTAIN THE LAWN, THEN A FEE OF \$20.00 WILL BE CHARGED.

18. QUIET TIME FOR PLAYGROUNDS AND RECREATION BUILDING IS **10 P.M.** UNTIL **9 A.M.** THE ONLY EXCEPTION IS IF THERE IS A SCHEDULED EVENT.

19 WASHROOMS ARE FOR THE APPLICANT CAMPERS USE- PLEASE KEEP THEM CLEAN

20. PLEASE OBEY THE SPEED LIMIT AT ALL TIMES - **5KM/PH.**

21. ANY TREES OR SHRUBS PLANTED ON THE CAMPSITE BECOMES THE PROPERTY OF THE PARK OWNER AND SHALL NOT BE REMOVED BY ANYONE OTHER THAN THE PARK OWNER.

22. THE APPLICANT CAMPER SHALL NOT SELL, TRANSFER, LEASE, SUBLET OR ASSIGN THE CAMPSITE OR THE TRAILER ON THE CAMPSITE AND/OR THEIR RIGHT TO OCCUPY THE CAMPSITE WITHOUT THE PRIOR WRITTEN CONSENT OF THE PARK OWNER. THE PARK OWNER HAS THE RIGHT TO WITHHOLD CONSENT AT ITS ABSOLUTE DISCRETION.

23. THE PARK OWNER ASSUMES NO RESPONSIBILITY FOR ANY LOSS THROUGH FIRE, THEFT, COLLISION OR OTHERWISE TO TRAILERS OR VEHICLES OR THEIR CONTENTS, REGARDLESS OF CAUSE. THE APPLICANT CAMPER AGREES THAT THE USE OF THE CAMPGROUND RESORT OR ITS FACILITIES IS SOLELY AT THE RISK OF THE APPLICANT CAMPER AND GUESTS.

24. **RELEASE** - THE APPLICANT CAMPER, ELIGIBLE CAMPERS AND GUESTS, FOR THEMSELVES, THEIR HEIRS, EXECUTORS, ADMINISTRATORS, SUCCESSORS AND ASSIGNS **HEREBY RELEASE, WAIVE AND FOREVER DISCHARGE** THE PARK OWNER, ITS AGENTS, SERVANTS, SUCCESSORS AND ASSIGNS **OF AND FROM ALL CLAIMS**, DEMANDS, DAMAGES, COSTS, EXPENSES, ACTIONS AND CAUSES OF ACTION, WHETHER IN LAW OR EQUITY, IN RESPECT OF DEATH, INJURY, LOSS OR DAMAGES **HOWEVER CAUSES** ARISING OR THAT ARISE BY REASON OF OCCUPATION OF THE CAMPSITE AND USE OF THE CAMPGROUND RESORT OR OTHERWISE, WHETHER PRIOR TO DURING OR SUBSEQUENT TO THIS **AND NOTWITHSTANDING** THAT THE SAME MAY HAVE BEEN CONTRIBUTED TO OR OCCASIONED BY THE NEGLIGENCE OF ANY OF THE AFORESAID. THE APPLICANT CAMPER FURTHER UNDERTAKES ON HIS/HER OWN BEHALF AND ON BEHALF OF THE ELIGIBLE CAMPERS AND GUESTS TO INDEMNIFY ALL OF THE AFORESAID FROM AND AGAINST ANY AND ALL LIABILITY INCURRED BY ANY OR ALL OF THEM ARISING AS A RESULT OF OR IN ANY WAY CONNECTED WITH THE LICENCE.

25. **PARK OWNER'S RIGHTS** - IF THE APPLICANT CAMPER FAILS TO PAY ANY FEES OR CHARGES OWING UNDER THE AGREEMENT, OR IF THE APPLICANT CAMPER OR HIS OR HER GUESTS FAIL TO ADHERE TO THE CAMPGROUD RESORT RULES OR BREACH OR DEFAULT ON ANY OF THE TERMS AND CONDITIONS OF THIS AGREEMENT, THE PARK OWNER SHALL HAVE FOLLOWING RIGHTS AT ITS OPTION.

- A) THE PARK OWNER MAY DISAPPROVE THIS APPLICATION AND/OR ANY SUBSEQUENT APPLICATIONS; AND/OR
- B) IN THE EVENT THIS APPLICATION HAS BEEN PREVIOUSLY APPROVED, THE PARK OWNER MAY, ON TEN (10) DAYS WRITTEN NOTICE, IMMEDIATELY TERMINATE THIS AGREEMENT AND REVOKE ANY LICENCE GRANTED UNDER THIS APPLICATION WITHOUT REFUND, AND RE-ENTER UPON THE CAMPSITE AND REPOSSESS THE CAMPSITE; AND/OR
- C) ANY DEPOSIT HELD BY THE PARK OWNER SHALL, AT THE PARK OWNER'S OPTION, BE FORFEITED AS LIQUIDATED DAMAGES AND NOT AS A PENALTY; AND/OR
- D) THE PARK OWNER MAYSUE FOR ANY OVERDUE FEES AND FOR CHARGES OR DAMAGES ARISING OUT OF A BREACH OR DEFAULT OF THIS AGREEMENT TOGETHER WITH INTEREST, LEGAL COSTS AND ANY OTHER COSTS OF ANY NATURE OR KIND WHICH MAY BE INCURRED IN REPOSSESSING THE SITE, REMOVING PROPERTY THEREFROM AND COLLECTION OVERDUE PAYMENTS OR DAMAGES; AND/OR
- E) THE PARK OWNER MAY BAR THE APPLICANT CAMPER, HIS/HER IMMEDIATE FAMILY, ELIGIBLE CAMPERS OR GUESTS FROM:
  - i) STAYING PAST 6:00 P.M. ON ANY NIGHT OF THE AFOREMENTIONED TEN (10) DAYS;

- ii) USING THE COMMON AREAS OF THE CAMPGROUND RESORT OR ATTENDING OR PARTICIPATING IN ANY COMMON ACTIVITIES AS MAY BE HELD IN THE CAMPGROUND RESORT; AND/OR
- F) THE PARK OWNER MAY EXERCISE ITS REMOVAL AND RECOVERY RIGHTS UNDER THIS AGREEMENT.

26. **ABANDONED-** THE CAMPSITE WILL BE DEEMED ABANDONED WHEN:

- BY OR BEFORE 4:00 P.M. ON MAY 1 IN EACH YEAR, THE APPLICANT CAMPER HAS NOT COMPLETED THE SEASONAL CAMPING LICENCE APPLICATION, RECEIVED APPROVAL OF SUCH APPLICATION BY THE PARK OWNER **AND** COMPLIED FULLY WITH THAT YEAR FEE AND PAYMENT SCHEDULE; **OR**
- BY OR BEFORE 4:00 P.M. ON OCTOBER 30 IN EACH YEAR, THE APPLICANT CAMPER HAS NOT OBTAINED APPROVAL FOR OFF-SEASON TRAILER STORAGE; **OR**
- AT ANY TIME, THIS AGREEMENT IS TERMINATED AND THE LICENCE GRANTED HEREBY REVOKED FOR ANY REASON.

27. **REPAIR AND STORAGE LIENS ACT** -IN THE EVENT THE CAMPSITE IS DEEMED ABANDONED UNDER THE TERMS OF THIS AGREEMENT, THE APPLICANT ACKNOWLEDGES AND AGREES THAT:

- A) EACH TRAILER, VEHICLE AND OTHER GOODS OR PROPERTY OF THE APPLICANT CAMPER REMAINING ON THE CAMPSITE OR LOCATED ELSEWHERE IN THE CAMPGROUND RESORT SHALL BE DEEMED TO BE AN "ARTICLE" AND DEFINED BY THE *REPAIR AND STORAGE LIENS ACT OF ONTARIO* (HEREINAFTER REFERRED TO AS THE "ACT") AND THE PARK OWNER SHALL BE DEEMED TO BE A "STORER" AND A "LIEN CLAIMANT" UNDER THE ACT WITH RESPECT TO SAME; **AND**
- B) EACH TRAILER, VEHICLE AND OTHER GOODS OR PROPERTY OF THE APPLICANT REMAINING ON THE CAMPSITE OR LOCATED ELSEWHERE IN THE CAMPGROUND RESORT MAY BE REMOVED BY THE PARK OWNER TO WHATEVER LOCATION THE PARK OWNER DEEMS APPROPRIATE, AND THE PARK OWNER IN SUCH REMOVAL AND STORAGE SHALL NOT BE LIABLE FOR ANY LOSS OR DAMAGE THEREBY OCCASIONED, **AND**
- C) THE APPLICANT CAMPER SHALL BE RESPONSIBLE FOR ANY AND ALL STORAGE COSTS AND MOVING COSTS INCURRED, TOGETHER WITH ANY OUTSTANDING FEES OR CHARGES OR ANY OTHER MONIES DUE UNDER THIS AGREEMENT; **AND**
- D) THE PARK OWNER MAY RECOVER SUCH COSTS, FEES, CHARGES OR OTHER MONIES OWING IN ACCORDANCE WITH THE PROVISIONS OF THE ACT.

28. A WAIVER OF ANY ONE OR MORE OF THE TERMS OR CONDITIONS HEREIN CONTAINED SHALL NOT BE DEEMED TO BE A WAIVER OF ANY OF THE OTHER TERMS AND CONDITIONS.

29. BY HIS/HER SIGNING OF THIS SEASONAL CAMPING LICENCE APPLICATION, THE APPLICANT CAMPER HEREBY REPRESENTS AND WARRANTS THAT HE/SHE HAS THE AUTHORITY TO SIGN ON BEHALF OF ELIGIBLE CAMPERS, GUESTS OR OTHER PERSONS ATTENDING AT THE CAMPSITE FROM TIME TO TIME.

30. WHEN THIS SEASONAL CAMPING LICENCE APPLICATION IS COMPLETED AND SIGNED BY THE APPLICANT AND THEREAFTER IS APPROVED AND EXECUTED AT THE DISCRETION OF THE PARK OWNER, THE APPLICATION BECOMES AN AGREEMENT IN SUPPORT OF A LICENCE TO OCCUPY THE WITHIN NOTED CAMPSITE.

31. THIS AGREEMENT AND LICENCE GRANTED HEREBY, INCLUDING THE SCHEDULES HERETO SHALL CONSTITUTE THE ENTIRE ARRANGEMENT BETWEEN THE PARTIES AND THE AGREEMENT DOES NOT INCLUDE ANY VERBAL REPRESENTATIONS OR WARRANTIES.

32. THE AGREEMENT AND ANY LICENCE GRANTED HEREBY SHALL BE BINDING UPON THE HEIRS, EXECUTORS, ADMINISTRATORS, SUCCESSORS AND ASSIGNS OF THE PARTIES HERETO.

**WAIVER AND RELEASE OF CLAIMS, ASSUMPTION OF RISK AND CONSENT TO MEDICAL TREATMENT**

Please read this document (the “Waiver”) carefully, as it affects your future legal rights. Please provide your initials on each numbered line after reading. By signing below, you (on behalf of yourself or your minor child/ward and any personal representatives, assigns, heirs and next of kin) acknowledge, agree and represent that you have carefully read and fully understood the Waiver and agreed to its terms. Each individual attending the Premises and/or participating in the activities of the Campground must complete and sign the Waiver. A parent/guardian of a minor Attendee must complete and sign the Waiver on behalf of the minor Attendee.

**BETWEEN:**

Happy Hollow Campground Inc. & Camper’s

This Waiver must be carefully read and signed in consideration of the opportunity of being a willing Attendee permitted to enter the Premises. As used herein, the term “Releasees” is defined to include the following: the Campground, its subsidiaries, affiliated organizations, owners, members, managers, directors, officers, past and present employees, agents, representatives, successors and assigns.

1. I expressly acknowledge and agree that my attendance at the Premises and participation in the activities of the Campground may involve the risk of serious injury and/or death and/or property damage.
2. I am fully aware of the risks and hazards inherent my attendance at the Premises and participation in the activities of the Campground and I voluntarily, knowingly and freely assume all risks associated with participating in the activities of the Campground and entering the Premises, including, but not limited to, my own actions or inactions (or the actions or inactions of my minor child/ward), the actions or inactions of others (including but not limited to the Campground owners, officers, directors, managers, staff, volunteers or visitors), falls, injuries, illnesses, infections, contact with others (including but not limited to the Campground owners, officers, directors, managers, staff, volunteers or visitors), navigating any and all obstacles and any defects of the Premises.
3. I represent and warrant to the Releasees that I am in good physical condition, am able to safely participate in the activities of the Campground and have no medical condition that would make my participation in the activities of the Campground more hazardous.
4. If I am pregnant, disabled in any way or have recently suffered an illness or injury; I consulted a physician before participating in the activities of the Campground.
5. I consent to medical care and transportation in order to obtain treatment in the event of injury to me as the Campground owners, officers, directors, managers, staff, volunteers or other medical professionals may deem appropriate and understand that this Waiver extends to any liability arising out of or in any way connected with such medical treatment or transportation.
6. I understand and agree that I am expected to exhibit appropriate behavior at all times while I am attending the Premises and while I am participating in the activities of the Campground to obey all local, provincial and federal laws, both criminal and civil. This includes, generally, respect for other people, equipment, facilities or property.
7. I understand and agree that I may not bring weapons or illegal substances to the Premises.
8. I understand and agree that the Releasees are not responsible for any personal item or property that is lost, damaged or stolen while I am participating in the activities of the Campground or on the Premises.
9. I recognize and acknowledge that there are hazards and risks of physical injury or illness to myself in attending the Premises and participating in the activities of the Campground and that not all such hazards or risks can be fully eliminated. I freely and voluntarily agree to assume the full risk of death, bodily injury or property damage, regardless of severity, that I (or my child/ward) may sustain as a result of my participation in the activities of the Campground or attendance at the Premises, howsoever arising, including, but not limited to, the active or passive negligence of the Releasees.
10. I agree to indemnify the Releasees from any and all third party claims, howsoever arising, for any loss, liability, damage or cost they might incur, including, but not limited to, claims arising in whole or in part by my negligent or intentional acts or omissions while participating in the activities of the Campground or attending the Premises.
11. I indemnify and hold harmless the Releasees from any loss, liability, damage or cost they may incur while I am participating in the activities of the Campground or while attending the Premises, howsoever arising, including, but not limited to, being caused by the negligence of the Releasees.

I hereby and forever release, waive, discharge and covenant not to sue the Releasees for any injury or damage to me, my personal representatives, assigns, heirs and next of kin, for any claims, causes of action, obligations, lawsuits, charges, complaints, controversies, damages, costs or expenses of whatsoever kind, nature, or description, whether direct or indirect, present or future, in law or in equity, in contract or in tort, or otherwise, whether known or unknown, arising out of or connected with my (or my minor/ward's) participation in the activities of the Campground or while attending the Premises, howsoever caused, including, but not limited to being caused by the negligence of the Releasees.

I hereby and forever release, waive, discharge and covenant not to sue the Releasees for any injury or damage to me, my personal representatives, assigns, heirs and next of kin, for any claims, causes of action, obligations, lawsuits, charges, complaints, controversies, damages, costs or expenses of whatsoever kind, nature, or description, whether direct or indirect, present or future, whether known or unknown, arising out of or connected with my (or my minor/ward's) participation in the activities of the Campground or attending the the Premises, under the terms of any statute, including, but not limited to, any claims under the Occupiers' Liability Act, R.S.O. 1990, c. O.2, as amended; and, the Negligence Act, R.S.O. 1990, c. N.1, as amended.
- 14. I understand and acknowledge that the laws of the Province of Ontario shall apply to all matters relating to this Waiver regardless of the activity location, that the exclusive jurisdiction for any dispute with the Releasees resides in provincial or in federal court in Ontario. I expressly consent to the exercise of personal jurisdiction in connection with any dispute with the Releasees arising from my participation in the activities of the Campground or while on the Premises of the Campground.
- 15. I expressly agree that this Waiver is intended to be as broad and inclusive as permitted by the law of the Province of Ontario, and that the invalidity or unenforceability of any term of this Waiver does not affect the validity or enforceability of any other term. Any invalid term will be treated as severed from the remaining terms.
